

Outstanding Senior Citizen County Nominations

Eligibility Criteria

1. The nominee must be a resident of Minnesota.
2. The nominee's volunteer service must be accomplished after reaching age 65
3. Nominee must be age 70 by June 1, 2015
4. Nominee must currently do a volunteer activity that is unpaid and demonstrates commitment to their local community
5. A previous county winner not chosen as state winner is eligible; however, a 2015 application must be completed
6. You may only nominate one individual per nomination form. Couple nominations will be disqualified.

Instructions

Give a detailed explanation on why you are nominating this person for the Outstanding Senior Citizen Award. It is very helpful to give specific, detailed, and precise examples to assist the judges in choosing the winners. Interviewing the nominee is highly suggested. Nominations do not need to be kept a secret. You are also allowed to talk to the organizations that the nominee volunteers at. Political and religious organization involvements will only be considered if these organizations benefit the community as well. All information submitted will be held confidential by the judges. Information that is submitted is not returned unless a request is made. The winner will be able to go on to the State Fair.

Judges will look for the following:

- Diversity of accomplishments
- How this person has touched the lives of other people in the community
- Total scope of activities, including years of service and time commitment
- Variety of services performed and involvement in organizations
- Quantity of accomplishments and amount of service **after age 65**
- Quality of activities, especially innovative services
- The area in which is covered by their services
- Individuals are encouraged to submit up to three letters of recommendation that focus on the candidate's achievements. **No more than three letters will be used in the judging process.**

Applications are due to the Fair Office by July 10th.

The recognition award ceremony will take place on Senior Day July 24th 2015 on the Gazebo stage.
