The Applicant agrees to set up between 9 AM-6 PM MONDAY or TUESDAY, JULY 22 or 23 and begin staffing the space by 12:00 PM WEDNESDAY JULY 24 and remain until 6:00 pm on SUNDAY JULY 28. NO Vehicles allowed on the Main or South Roads prior to 6:30 PM on Sunday July 28. The Applicant shall hold the Scott County Fair, its agents and directors harmless from any and all claims or causes of actions made by any person against the Scott County Fair arising out of any actions or conduct of the Applicant, its agents or employees.
