- You must meet the age requirements stated on the application and live in Scott County, MN.
- You must be responsible, professional, and have leadership experience with the desire to continue to grow as a leader.
- Your term will run for two years, but you may re-apply each year until you turn 19.
- You may be removed at any time during the year for inappropriate, unacceptable behavior or for not fulfilling your duties.
- Always carry a professional attitude when handling fair attendees.
- Work with members of the Scott County Fair Board when help is needed.
- Use appropriate dress, behavior and language, especially when representing the Scott County Fair.
- Support the decisions, policies, and activities of the Scott County Fair Board Junior Fair Board.
- You will be expected to work during fair set up, fair week, and clean up. You must make every effort to attend the junior fair board meetings
